

**Minutes of the Regular Meeting of the

Scott Wenz, Cars are Basic, addressed the board on SBCAG and their funding of programs requesting that bikeway funds be redirected to road improvements and expressed concerns about the MTD electric buses and lack of recent audit.

Sherrie Fisher, General Manager SBMTD stated that the agency is frequently subject to state and federal audits and copies of audits are available to the public.

12. COMMITTEE REPORTS

Appointment of members Hicks and Firestone to executive committee by Chair (Existing members of committee include members Armendariz, Bennett and Alvarez)

At the direction of the Chair, members Hicks and Firestone were appointed to the executive committee.

13. EXECUTIVE DIRECTOR'S REPORT

Jim Kemp reported the Highway 154 project over San Marcos Pass, solely funded by Measure D funds, has gone out to bid. If an acceptable bid comes in it will be awarded sometime in June and construction will begin in July. Project improvements are considered spot operational and safety improvements.

Supervisor Wolf suggested using CSBTV and radio station 1210 to get information out on the Highway 154 and the Milpas to Hot Springs projects.

Clean Air Express, operated by SBCAG, has been experiencing overloading which has caused riders to be turned away. The Clean Air Express will be considering a policy that will allow passengers to stand on the buses. Currently there is no standing permitted.

Mayor DeWees asked if there would be a Clean Air Express rate increase due to the high gas prices. Mr. Kemp reported that a fare increase was implemented in January and another has been approved by the board for January 2008 and he will look at the fuel costs and see if they are impacting the operation.

SBCAG and SLO partnered together to participate in a Blueprint Planning Grant application to the state. The Santa Maria Valley would serve as a pilot program and SBCAG and SLOCOG will work to incorporate local agencies in this effort. SBCAG and SLOCOG had requested almost \$500,000 to complete this Plan and were actually only awarded a total of \$270,000. Will have to discuss with SLOCOG how best to use the money awarded to accomplish the project objectives.

SBCAG just completed a Planning Certification Review with the Federal Department of Transportation.. Preliminary findings were positive there were no corrective actions that were identified. Within the next 3 months there will be a final report that SBCAG will share with the board.

14. CALTRANS DISTRICT DIRECTOR'S REPORT

Rich Krumholz, Caltrans District 5 Director, reported that the Board received in their packet a copy of the Caltrans monthly report with information about ongoing and upcoming construction projects.

The week of April 7th Caltrans held memorial services around the state for the fallen Caltrans workers. Each April Caltrans tries to raise the public awareness of going slow in the cone zone.

There will be full closure of highway 192 in Santa Barbara expected to last until the end of June. The Highway will be closing in order to realign the highway. Total closure is required because Caltrans had to squeeze the project in between the rainy season and fire season.

The Las Vegas and San Pedro Creek project was funded by SHOPP funds for 17 million dollars because the County of Santa Barbara Flood Control department produced the environmental document.

Councilmember Skytt would like Caltrans to look into the possibility of adding stop signs at other intersections along highway 154 (ie., Roblar, Los Olivos)

Supervisor Carbajal would like to have a meeting with Caltrans and the Mission Canyon Committee regarding issues the committee has with the design of the project.

Supervisor Gray inquired about the status of the signal to be installed at highway 1 and 166.

15. COMMUNICATIONS

Jim Kemp reported that the groundbreaking ceremony for the US 101 Milpas to Cabrillo-Hot Springs Project has a tentative scheduled date of June 11, 2008. Have received confirmation that Caltrans Director Will Kempton will be available to attend . In response to the SBCAG board's invitation, the Governor's staff indicated that they are not able to confirm his attendance at this time. The ceremony date may have to be moved in order to accommodate the Governor.
